#### **GREETINGS AND WELCOME!**

This is the fourth issue of *The Lash*. the newsletter of the newly formed Treasure Valley Whips driving club. The TVW is a non-profit association with the purpose of recreation, competition and education of drivers of all types of equines. This club is organized to aid those that are interested in developing driving skills that will provide the basis for safe and sound driving habits and skills that can lead the driver to better enjoy recreational driving and competitive driving, depending on interest. Drivers of varying interests and abilities are welcome and will be included in TVW activities.

### **MEMBERSHIP DRIVE 2006**

This year has been a great start for our driving club. Many events and activities have been held and many more are planned. None of this is possible without membership support. There are many "overhead" expenses involved in a club of this nature not the least of which is the club's liability insurance. There are also equipment needs that so far have been met by the generosity of individuals in the club. This was certainly appropriate for a club in its first year, but we must start making plans for the future to determine if there is sufficient support to continue. We are therefore beginning our 2006 membership drive. As an incentive to non-members to join, and for current members to renew, in the future, all TVW events will remain open to the public, but members will enjoy membership discounts for entry and other participation fees. We believe that those who join and thus help pay overhead costs should benefit from that investment. For example, we will need to increase our play day participation fee to \$15 per participant with a horse(s), but will discount that price by \$5 for members – so members will pay \$10. Non-member participants without horses will pay \$5. There will be no charge for members attending without horses.

Within 1/4<sup>th</sup> of a mile you'll see a blue private lane sign, HESTEHAVEN, turn right. Parking area is straight ahead by the arena.

#### MEMBERSHIP DRIVE AND INFORMATION

The Treasure Valley Whips (TVW) carriage driving club was started last fall in order to promote the sport of carriage driving over a broad spectrum from recreational pleasure driving to formal competition. This year, the club has sponsored six play days, three arena driving trials, two cross country drives, a clinic and barbeque, with more play days, a pleasure driving show and an endurance drive yet to come in 2005. We publish a newsletter, in which we report on club events and notify members of upcoming events. We plan on continuing this activity level and more for 2006. Check out the latest copy of the club's newsletter, The Lash, for more information.

In order for the club to exist and offer these popular events to the public, it relies on membership to pay the basic overhead costs, e.g. insurance, equipment, supplies, etc. Many members have donated a significant amount of their time and resources to starting this club up, but its continued existence must be guaranteed by a strong membership.

In the future, all TVW events will remain open to the public, but TVW members will enjoy membership discounts for entry and other participation fees. We believe that those who join and thus help pay overhead costs should benefit from that investment. For example, we will need to increase our play day participation fee to \$15 per participant with horse(s), but will discount that price by \$5 for members. Non-member participants without horses will pay \$5 and there will be no charge for members attending without horses.

# Therefore, the 2006 membership drive is already underway:

- If you are a current member of the TVW (2005): you may renew your current membership for \$25, instead of the regular \$30 for an individual membership. Family and Youth memberships will also enjoy a \$5 discount. This offer is effective now through October 31, 2005.
- If you are not a member, and would like to join: You may join for the remainder of 2005 and all of 2006 for \$40; Families \$55; and Youth (under 21) \$25. (Regular one year membership fees are: \$30, \$45 & \$15, respectively) This will entitle you to discounts at the remaining play days (Oct. & Nov.), endurance drive (Sept) and pleasure driving show (Oct.) this year as well as all club events next year.

All classes will be offered in separate sections unless indicated as "OPEN";

- Section A classes: small ponies and miniature horses (13.2 hands and under);
- Section B classes: large ponies and horses (over 13.2 hands);
- Section C. Multiples (any size) for morning classes. Afternoon classes, show in appropriate size section, A or B.
- Other equines welcome, just enter appropriate size category.

**Entries**: \$7.50 a class, \$30 per horse for all day. \$15 non-member fee. **Awards**: Ribbons 1<sup>st</sup> – 4<sup>th</sup> each class. **Champion and Reserve Champion Section A. B. & C.** (high point; **must show in Reinsmanship**; point system: 1<sup>st</sup> – 5pts; 2<sup>nd</sup> –3pts; 3<sup>rd</sup> – 2pts; 4<sup>th</sup> – 1pt.)

#### **SCHEDULE**

### 9:30 am - Indoor Arena - Morning classes - hats, gloves & aprons required:

- 1. **Pleasure Driving Turnout -** Section A. then Section B. then C.
- 2. **Pleasure Driving Working -** Section A. then B. then C.
- 3. **Pleasure Driving Reinsmanship -** Section A. then B. then C.
- 4. **Picnic Pleasure** OPEN –Each exhibitor will show at a walk and working trot in the arena. The cart or carriage should carry some form of picnic lunch basket or other container and appropriate accourtements. Then lunch break will be taken. The judge(s) will visit each entry to judge their picnic lunch spread back by their trailer or in another designated area (probably in the shade!) Awards will be announced during the lunch break. Judges may sample the "wares". "Bribes" in the form of food are encouraged. To be judged on turnout, picnic set-up, imagination, food and the judge(s') general whimsy.

- 5. **Pick Your Route Obstacles -** Section A. then B.
- 6. Gambler's Choice Obstacles Section A. then B.
- 7. **Ground driving "trail" class** OPEN Open to equines not yet shown in driving. Will use the obstacles from the previous class but will have a set course. Will not be timed. Shown at walk through the obstacles. Judged on manners, willingness and obedience.
- 8. **Timed Marathon type hazards -** Section A. then B.
- 9. **Ground Driving marathon hazards** OPEN same criteria and eligibility as class #7 but will use the hazards from class # 8.

# NO DOGS ALLOWED AT THE BIRT ARENA FACILTIY – THE BIRT'S INSURANCE REQUIRES THIS – PLEASE COMPLY

### (Complete specifications in the ADS pleasure driving rules)

<u>Turnout</u>: To be judged primarily on the performance and quality of each turnout. To be shown both ways of the arena at a walk, slow trot, working trot and strong trot. To stand quietly and to rein back. Judged: 70% on the condition, fit and appropriateness of the harness and vehicle, neatness and appropriateness of attire and overall impression. 30% on performance, manners and way of going.

<u>Working</u>: To be judged primarily on the suitability of the horse to provide a pleasant drive. To be shown both ways of the arena at a walk, slow trot, working trot and strong trot. To stand quietly, both on the rail and while lined up, and to rein back. Judged: 70% on performance, manners and way of going of the horse(s); 20% on the condition and fit of the harness and vehicle; 10% on neatness of attire.

**Reinsmanship:** To be judged primarily on the ability and skill of the driver. To be shown at a walk, slow trot, working trot, and strong trot. Drivers shall be required to rein back. All drivers selected for a workout may be worked at any gait requested by the judge and may be asked to execute a figure of eight and/or perform other appropriate tests. To be judged: 75% on handling of reins and whip, control, posture, and overall appearance of the driver; 25% on the condition of the harness and vehicle and neatness of attire.

<u>Pick Your Route</u>: To be driven over a course of obstacles with no set route. The obstacles are set at 2.5 meters (8'3") wide. After passing the starting line, the driver shall proceed through each obstacle to the finish line, choosing his/her own route. <u>Each obstacle is to be negotiated once and only once but may be approached from either direction.</u> Course faults are scored as penalty seconds and are added to the driver's elapsed time – Lowest score wins. <u>Gambler's Choice</u>: Each driver will have the same amount of time to drive an unnumbered course driving as many obstacles as possible, each one assigned and marked with a specific point value. The object is to amass the highest total points within the time allowed. After passing through the starting line, the driver may drive the obstacles in any order and any direction. Each obstacle may be driven twice, but not in succession. No score for obstacles disturbed by the horse/carriage or incorrectly completed. Disturbed obstacle cannot be redriven. No circling/refusal penalties. Once the time limit expires, a signal will sound. Driver must then go through the finish markers. High score wins. Lowest time will decide ties.

<u>Timed Marathon Type Hazards</u>: Two marathon type hazards will be set up. Exhibitor will pass through start/finish gate of hazard #1, drive through the lettered gates of the hazard in order, A, B, C, and D and come out start/finish gate. Timer will signal when ready for driver to drive the second hazard. This process is repeated until the Exhibitor has driven the hazards #1, #2, #1, and #2. Lowest (fastest) score wins.

<u>Cones – Timed</u>: Traditional cones/obstacle driving class. A pre-set course will be set up and timed. Minimum clearance will be approximately 16". Course penalties added to time. Lowest score wins.

<u>Double Jeopardy</u>: Entry consists of two drivers in one carriage. First driver goes through the start and drives the course to the finish marker. After passing the finish marker and coming to a COMPLETE HALT, the second driver takes the reins and drives back through the start/finish, through the course backwards and again through the start/finish markers. The reverse course will be marked with numbers on different colored markers. Best time wins; course penalties are to be added to the time. Failure to come to a complete stop to change drivers may result in a 10 second penalty at the judge's discretion.

Take a left at the second stoplight from the freeway (at the corner of Mercy North and McDonalds); this is Happy Valley Road. Take Happy Valley Road to Amity and take a right. Follow Amity to Southside Blvd and take a left on Southside (just over the tracks). Follow Southside approximately 2-3 miles to Lewis Lane and turn right. Within 1/4<sup>th</sup> of a mile you'll see a blue private lane sign, Hestehaven, turn right. Follow to the parking area straight ahead by the arena.

Each Arena Driving Trial will be a daylong event, featuring three phases: 1. Driven Dressage, 2. Hazards, and 3. Cones. This is an excellent opportunity to learn more about combined driving events (CDE's) and for those who are familiar with the sport to work on their skills. Dress is informal and helmets are recommended for drivers and anyone riding on a cart/carriage. No cantering in the hazards in Training level. **Cones Information**: Timed event, one multiple ("L" "double L" or serpentine); **Training**, minimum of 50 cm clearance; **Preliminary**, min. 40 cm clearance. No cantering.

The Treasure Valley Whips hold several play days each year. These events are open to anyone who is interested in learning more about driving, from beginners to experienced drivers. Many of them are held at the Birt Arena facility in Nampa, Idaho. There are several areas that can be used at the facility, depending upon the weather. We typically include a "bomb-proofing" area with lots of flags, plastic, tires, etc. to get our horses accustomed to, usually while leading them through the area. This makes the play day an excellent place to bring a green or young horse for some experience. We also set up some driving courses (e.g. cones, hazards, & dressage) for participants to learn and to practice. Our participants include folks who are leading their horses, ground driving

The schedule is kept fairly unstructured, so that the participants can set their own pace, but occasional demonstrations and lessons are offered as well. As our club grows, more and more members are available for putting on demonstrations and giving lessons at these play days depending upon participant interest.

them, driving hitched to a vehicle, as well as those who are just coming to get more information or catch a ride. The club also sets up an information table with all sorts of articles, magazines, pamphlets, catalogs and other educational information about driving.

This fall and next year, we will hold a few of our play days the same weekend as a driving show or arena driving trial (Oct., Feb. and March). Hopefully, the play day will give participants a chance to practice on Saturday before the show or trial on Sunday in the winter months. The Birt's also now have completed their stable that includes 18 wonderful stalls. This will enable folks who want to come from out of the area with their horses to participate, as well as those of us who would like to overnight our horses for the show or trial the next day. The stalls will be available for rent. There are also electrical hook-ups for RV's available as well. Contact the show/trial organizer for more information.

The play days are open to the public, but membership is rewarded with a discount. Cost is \$10 per member bringing a horse(s); \$15 for a non-member bringing a horse(s); Play days are free to members coming without horses and \$5 for non-members coming without horses. These fees are used to defray the costs of the facility rental, insurance, equipment, etc. Members get a discount, because they invest in the club to fund the overhead expenses. If you are not a member, look into joining. The club needs members to cover annual expenses, and you will ultimately benefit financially!
